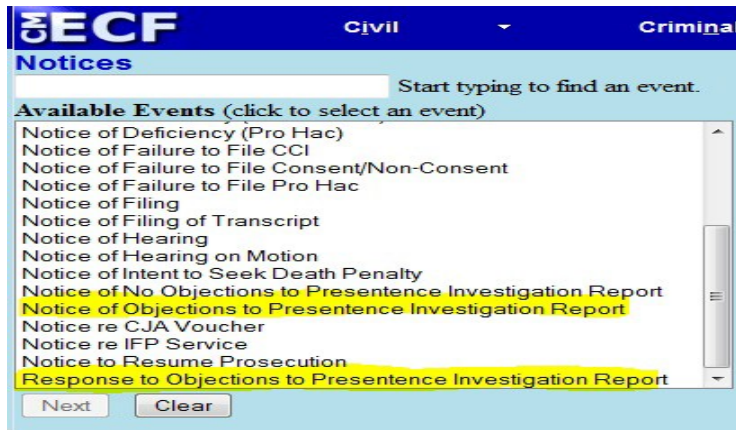


PRESENTENCE INVESTIGATION REPORTS

To file objections or a notice of no objections to the Presentence Report in CM/ECF, follow the instructions below.

DOCKET THE NOTICE

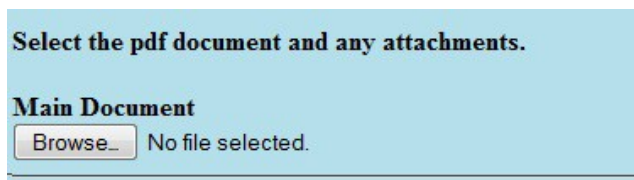
1. Choose Criminal.
2. Under Other Filings, Notices, select Notice of Objections to the Presentence Investigation Report OR Response to Objections to the Presentence Investigation Report.
Please note that the procedure for filing a Notice of No Objection to Presentence Investigation Report has not changed.



3. Enter/verify the case number and select the appropriate defendant(s) and select *Next*.



4. Browse for and attach the pdf document to be uploaded and select *Next*.



5. Select the defendant that the Presentence Report relates to and the USA. (*This screen selection represents which parties will be given access to the filing.*)

WARNING: All parties selected will have access to the filing. Do NOT select any co-defendants.
